1.	Did the school board or other Salem High School leaders participate in development of this club?	Absolutely, we met over the course of the past year with Salem High School Administrators, Salem City Schools Central Office, and the City of Salem School Board. Their input and support have been invaluable.
2.	What makes this organization different than the Salem Sports Foundation?	We are a non-profit organization and all donations are tax deductible. We allow the giver to “designate” their donation to a particular sport, donate to all sports (without designation), or into the general fund of the club itself.
3.	Are you replacing the Salem Sports Foundation?	The 24153 Club is not intended to replace the Salem Sport Foundation. The Salem Sports Foundation has a long, proud history in Salem for helping the student athletes of Salem High School. Both organizations will be an integral part of supporting student athletes in Salem.
